Terms and Conditions:-

- The quotation should be submitted in a sealed envelope superscripting "**Supply of Immersion rods, Heat convectors and Heaters, PPR-57/10**" and must reach this office duly addressed to the undersigned on or before **06-07-2010 by 1300 hrs.** This shall be opened on same day at **1500 hrs.** in the presence of authorized representatives of suppliers/manufactures, if any.
- The parties must submit their Sale Tax No. and PAN Card along with their bid.
- The complete brochure of the item quoted, showing the complete specifications and make should also be attached with the bid.
- Rates and amounts shall be quoted in both figures and words (figure will prevail) clearly on the prescribed format attached as Annexure-I.
- Rates:** Rate shall be quoted Ex-shop, inclusive of all taxes & packing and should be valid for minimum 60 (sixty) days from the date of opening of quotation.
- Sales Tax, VAT, Local Taxes and Octroi:** Indicate clearly the rates of applicable sales tax, local taxes and octroi, if any, else these would be considered to have been included in the rates.
- Payment:** **90%** payment within 30 days after receipt of items/goods and on submission of invoice/bills. The remaining **10%** payment shall be released after completion of the guarantee/warranty period.
- Delivery Period:** Within 30 days from the date of issuance of the supply order.
- L.D. Charges:** In case the item is not supplied within the specified period, SJVN Ltd. shall be at liberty to cancel the order in full or part. However, for late delivery, a penalty @ 0.5 % per week or part thereof, subjected to maximum of 5% of the value of the item delivered late shall be imposed.

11. **Inspection:** Inspection shall be carried out by the Consignee or his authorised representative at the time of taking delivery of items/materials.
